### **TCC Tenets of Pastoral Oversight:**

1. All who represent TCC are required to be in consistent fellowship and to be referred to service with TCC by their own Pastor.
2. Any Pastor who refers a person to us must agree to provide oversight of the person's walk. He will be affirming that the candidate is orderly and in full fellowship, has a transparent relationship with the Pastor himself, and that both are committed to the health and subsequent growth of this relationship.
3. The Pastor and candidate must agree that should the conditions affirmed change at any time, the Pastor will inform TCC immediately.
4. TCC will not be taking over pastoral oversight of any person, but will engage in discipleship as is appropriate among brethren and evangelists.
